Who are we?

Rhino Sands Safari Lodge is located in the Manyoni Game Reserve, South Africa. We offer luxury safari experiences and accommodation services.

The information we collect

Personal data refers to information that can uniquely identify or contact an individual. We collect and process personal data necessary for managing bookings and providing our services. This may include:

- Name
- Address
- Email address
- Phone number
- Credit card information
- ID or passport number
- Travel information
- Records of interactions with us

We retain personal data for as long as is reasonable to fulfill contractual obligations, comply with legal requirements, and for legitimate business purposes.

How do we collect your information?

We collect information directly from you when you:

- Communicate with us via phone, email, or our website.
- Make a booking through our website or via an online travel agency.
- Use our website, where we collect technical information such as IP address, browser type, and operating system.

How might we use your information?

We use your personal data to:

- Process bookings and manage accommodation services.
- Provide you with information, products, or services you request from us.
- Improve our services, conduct data analysis, and perform internal operations.
- Facilitate payment processing and guest communication on behalf of our clients.

How do we process your information?

We process your personal data to provide our services and manage bookings. Our clients (the accommodation provider) enter their information into our system and maintain their data.

Conditions for sharing your information

We do not share or sell your personal information. We may share your data only with:

- Affiliates, under conditions that they honor this privacy policy.
- Credit bureaus to report account information, as permitted by law.
- Legal authorities, if required by subpoena or court order, to comply with any law, or to protect the safety of individuals or the public.

Security of personal information

We take reasonable measures to secure your personal information from accidental loss and unauthorized access. These measures include firewalls, data encryption, and restricted access to personal data.

However, please be aware that no security measures are perfect. The safety of your information also depends on you. We cannot guarantee the security of information transmitted to our website, and any transmission is at your own risk.

Client responsibility advisory

We reserve the right to suspend a client connection if we suspect data protection policies are being violated.

Our subscriber policy
